4. The applicant hereby agrees that:

- a. David Whyte expressly reserves ownership of all rights in and to the poem, or excerpt (including but not limited to copyrights); and to the extent that any contribution made by the artist and embodied in the artwork might amount to a copyrightable contribution, the artist hereby grants to David Whyte a perpetual, non-exclusive license of those rights sufficient to allow David Whyte, his employees and/or agents to copy, distribute, and/or publicly display an image of the artwork solely for the purpose of promotion of David's work(s), including but not limited to use of the image in online web pages and printed brochures so long as the promotional materials themselves are provided free of charge. The artist agrees to provide to David Whyte a .jpeg file of a photograph of the artwork (of suitable quality for reproduction in print) for use only in accordance with the provisions of this paragraph.
- b. The artist agrees that permission granted herein is limited to the use of the exact wording and the artist does not have permission to edit, paraphrase, or re-phrase the poem or any portion of the poem.
- c. The artist agrees to place on either the back of, bottom of, side of, or on a label attached to the Artwork the following attribution:

- d. If the artwork is sold, then the artist agrees to pay to David Whyte \$95 within 30 calendar days following the sale.
- e. Permission is not granted for artist to incorporate the artwork into any other form of derivative work or merchandise. By way of example: This grant of permission does not extend to use of the artwork on coffee mugs, greeting cards, or other types of merchandise.

- f. Permission is granted for artist to make copies of and to distribute or publicly display an image of the Artwork solely for the purpose of promoting artist's work, including but not limited to use of the image in online web pages and printed brochures so long as the promotional materials themselves are provided free of charge.
  - g. This permission is granted to ARTIST only. It is non-exclusive, non-transferable, and limited to the use specified in this agreement.
  - h. This document is the final expression of the agreement between artist and David Whyte and is a complete and exclusive statement of the terms of their agreement. No modification or waiver of any provision shall be valid unless in writing and signed by both artist and David Whyte.
